NOTICE TO BIDDERS**

The Sycamore Park District is accepting bids for the following identified project:

**Memorial Park OSLAD Development**

The proposed work is located west of the Sycamore Park District Community Center Building Airport Road in Sycamore, IL 60178. The project consists of the provision of materials, labor and equipment necessary to fabricate, furnish, and install the improvements as shown on the Final Engineering Plans and as described in the specifications. Major work elements include topsoil stripping, mass grading, baseball field and fencing installation, storm sewer installation, water service installation, electric service installation, parking lot and trail paving, turf grass seeding, native seeding, landscaping, installation of a pavilion, installation of a playground, installation of a disc golf course, installation of a bocce court, and various additional site features.

Sealed bids plainly marked "Memorial Park OSLAD Development" and addressed "To Jonelle Bailey, Executive Director" shall be received on or before **11:00 a.m. on Thursday, May 13<sup>th</sup>, 2021** at the Sycamore Park District Community Center: 480 S. Airport Road, Sycamore, IL 60178, at which time bids will be publicly opened and read aloud. Bids received after this time will be returned unopened. No oral proposals or modifications will be considered. No bidder may withdraw his proposal after the hour set for the opening thereof, or before award of the contract, unless said award is delayed for a period of exceeding sixty (60) calendar days. **Please note that within three (3) working days after the bid opening, the two (2) low bidders shall provide a letter from a surety company indicating that bidder's ability to secure a surety bond. Requirements for that letter are included in the bid proposal documents.**

The chosen Contractor shall comply with all provisions of the Illinois Prevailing Wage Act. Sycamore Park District is an Equal Opportunity Employer.

The successful contractor(s) must be able to provide a satisfactory Performance Bond, Labor and Material Payment Bond and required proof of insurance following the award of a contract.

This project is being financed, in part, with funds from the Illinois Department of Natural Resources, "Open Space Lands Acquisition & Development" (OSLAD) grant program.

Minority business firms are encouraged to submit bids. Successful contract bidders are also encouraged to utilize minority businesses as sub-contractors for supplies, equipment, services, and construction.
