Planning Commission Report: Commissioner Strack noted there was no meeting.

Presentation of Audit: Jen with Lauterbach & Amen presented the audit to the board.

Commissioner Strack moved to accept the audit as presented. Commissioner Doty seconded the Motion.

President Kroeger called for a roll call to approve the motion. All commissioners present voted Aye. Motion carried 4-0. Commissioner Graves was absent.

Old Business:

Construction Updates:

- <u>Founders Park:</u> Supt. Donahoe noted that he received an email that the bracket for the playground is on it way. The spinner is mid-June arrival. So, when we get the bracket, they can get that part done and tape off the area the spinner is in. They have been keeping the residents informed on this.
- <u>Pool Updates</u>: Supt. Donahoe noted the pool is filled and working. The new heaters are great. They had a problem today with some broken lines in bathrooms, but this is being fixed. The splashpad is going. The State Boiler Division inspected the heaters. With the different new heaters, the State said we had to have emergency shutoff buttons, so we are getting those installed. The guards should be in the pool next Tuesday and plan on opening on the fourth.
- **GWT Status:** Director Bailey noted she had email conversation with Roger on some of the areas. She went over all of this with the board. So far we are still on target to finish by the end of the year.
- Riverside: Supt. Donahoe noted it was a wet start and the fields were holding some water. He is having a company come out and do deep tine aeration which should help the surface water drain. This cost is being split with AYSO. The north fields did not come in as thick as the other fields. They are not allowing adult league until the fields are strong enough for adult traffic. His crew continues to slit seed and fertilize the fields to help with all of this. President Kroeger noted he is hearing complaints about parking and wondered what we are doing to help resolve this. He asked if the schedules could be changed. Supt. Donahoe noted it is all up to AYSO. It is working with the help of the grass parking. For some reason AYSO must have a board member present so they want their games all on one day during a certain time frame. Commissioner Strack asked if AYSO has paid their balance for their LAL pledge. Supt. Tevsh noted AYSO said they needed one more paying season to finish it up. Supt. Hienbuecher noted their balance is about \$16,000. Commissioner Ackmann asked if anyone has asked about the lightening detection system over there. She had heard that the head of the league was not there, and the coaches did not know what to do when lightening

<u>Riverside – cont'd:</u> struck but no lightening detection siren went off. Supt. Donahoe noted that too many people rely on the system. If anyone sees lightening, they should be done. The system only reads static and if not enough static on the ground it will not go off. He said he can look into the cost of a system for out there. Supt. Tevsh noted this should be added to the MOU's that the organizations are responsible for a procedure for lightening.

Memorial Park: Director Bailey noted that Supt. Donahoe has looked at the alternate options that William Charles provided. Supt. Donahoe noted this is regarding the curbing on the southeast field due to change in elevation. He is talking to Chad Thursday to see if feasible. Director Bailey noted the concrete option is about \$1500 more than the other option. Without the concrete curb the fields can be washed out. The concrete curbing will be less maintenance, etc. over the years. Director Bailey noted we must get this project finished by mid-June, so we need to know what direction the board wants to go. Director Bailey noted that ERA has reviewed the cost and they said it's in a reasonable range.

Motion

Commissioner Strack moved to approve the concrete curbing option. Commissioner Doty seconded the Motion.

President Kroeger called for a roll call to approve the motion. All commissioners present voted Aye. Motion carried 4-0. Commissioner Graves was absent.

Director Bailey noted she received a call from one of the neighbors. Supt. Donahoe noted this mound was planned all along. Director Bailey noted there is one neighbor that is upset. She is concerned about their view, and they will have people peeing in their yard and people being too close to her property. She did let her know that we are still removing dirt and will be seeding it. The neighbor wants it completely gone and Director Bailey told her that it will not be. Supt. Donahoe noted it is probably at the finale shape of the mound.

SPF Update: Director Bailey noted they did really well in the first few months collecting money. The next fund raisers will be the summer concert will be June 30^{th} and the golf outing will be July 2^{nd} .

Also, with the park district growing, we need the space. With the part time staff for Admin, she moved to this area. So, we are using this space. The communication has been great with NW still.
