<u>Public Input</u> – Commissioner Strack started a discussion regarding the trail by North School. Director Bailey asked him to get an estimate on the cost and she would also need to know the exact location and length.

Positive Feedback:

Plan Commission: No report.

Old Business:

<u>Drainage Report:</u> Supt. Donahoe noted that for a few years the City has talked about improving the drainage from the west of Parkside Drive to around 7 tee. To help the drainage they want to put in a 30" pipe next to the creek. President Kroeger asked if they would be increasing the culvert and Supt. Donahoe was not sure at this point. Supt. Donahoe showed the layout on the screen. Commissioner Strack asked if it would bottleneck when it goes back down to just the creek. Commissioner Strack and Kroeger were concerned it would flood our property. Commissioner Strack asked why they couldn't put in a detention pond instead of the pipe along the creek. Director Bailey noted she is not sure about a detention pond since we don't want any more ponds. Supt. Donahoe noted some of his concern is the timing on when this would be done and our irrigation line.

Construction Updates:

- **GWT**: Director Bailey noted we have received the ok from IDOT to move forward. We are in the process of getting the assessment, which could cost an additional amount. We will need to pass an ordinance stating our Director can sign off on the project.
- **Reston Ponds:** Director Bailey noted the wind screens are up and everyone is pleased with them. Working on tree planting grants.
- <u>Solar Panels:</u> Supt. Donahoe noted there will be 1 more Com Ed power shut off at the maintenance shop. There are 13 steps in the process and they are 90% done in step 10 so they are close. They are saying it should be done the end of November.
- <u>Pool Building:</u> Director Bailey noted we found out that Belvidere has demolished their pool building so she has a call into them. This will help us get some better pricing. The earliest this will be is 2026.
- North Grove: Director Bailey noted we have the final plans for construction. Permits were submitted and we are looking to open bids in December.
- <u>Riverside Soccer Complex:</u> Director Bailey noted the bid opening for this will be November 13th.
- Community Gardens: No update.
